Jurors who do not sit on a jury may serve for as little as 1-2 days. However, even if not needed for a

trial a juror may be asked to be available or on call for up to five days. Those who are selected to serve on a jury are required to serve on only one trial. The judge informs the jurors how long the trial is expected to last. Length of service
