ODISHA GOVERNMENT LEAVE RULES & REGULATIONS

(1) These rules may be called the Orissa Leave Rules, 1966. (2) They shall come into force from the 1st August, 1966. 2. (1) These rules apply to all Government servants in Class-I, Class-II and Class III State Civil Services, except-(a) in the case of Government servants who served in the Province of Bihar and Orissa prior to the 1st April, 1936.

7.1 LEAVE RULES 7.1.1.Introduction Leave is a provision to stay away from work for genuine reasons with prior approval of the authorities. It may be granted for a casual purpose or a planned activity, on medical grounds or in extra-ordinary conditions.
